

## LFC Sports Nutrition and Wellness Promotion Terms and Conditions

These terms and conditions outline the rules and regulations governing the participation in the Online Raffle organized by Vector Consumer Limited ("the Company"). By entering the raffle, participants agree to abide by these terms and conditions.

### 1. Eligibility:

The Online Raffle is open to individuals aged 18 years and older at the time of entry. Employees, agents, and affiliates of the Company, as well as their immediate family members, are not eligible to participate.

### 2. Entry Requirements:

To enter the Online Raffle, participants must complete the following steps:

Submit their full name, email address, telephone contacts, and a picture of the receipt of purchase. The receipt of purchase must indicate a Qualifying Purchase, as defined in section 5.

### 3. Prize:

The prize for the Online Raffle is 10,000 (Ten Thousand) AED in a single cash payment and LFC Supplements up to 3,000 (Three thousand) AED retail value. The Company reserves the right to alter the length of the competition and may alter the prize within equivalent cash value.

### 4. Winner Selection:

Winners will be selected through a random draw from all eligible entries received during the promotional period. The draw will be conducted by the Company or a designated representative.

### 5. Qualifying Purchase:

A Qualifying Purchase refers to a transaction between the participant and any of the following Retailers where the Product is sold:

### 6. Promotional Period:

The promotional period for the Online Raffle will be specified by the Company. Entries received before or after the promotional period will not be considered.

## **7. Winner Notification:**

The winners will be notified via the contact information provided during entry (email or telephone). The winners must respond to the notification within 7 days of the initial contact. Failure to respond within the specified time may result in disqualification and the selection of an alternate winner.

In case the winner does not respond within 7 calendar days, a second runner-up winner will be selected, who will be required to respond within further 7 days, and so on until a successful winner is identified and contacted.

## **8. Prize Delivery:**

The prize will be provided to the winner within a reasonable timeframe after confirmation but no more than 15 business days. The Winner needs to indicate their choice to the Company whether they choose a Bank Transfer as means of Prize payment or hard cash. The Winner will be provided with indication of how the year's supply of LFC supps will be provided to them via a direct contact to the Company or its local Agent / Distributor. The Company is not responsible for any delays in prize delivery / provision due to reasonably unforeseen circumstances and will not accept any claims against it for any such delay.

The Company reserves the right to amend, modify, or terminate the Online Raffle or these terms and conditions at any time without prior notice.
